

MDCC Campus Police Parking Regulations

PERMITS

Parking on campus is by permit only.

PARKING AVAILABILITY

Purchase of a permit or decal does not guarantee a PARKING SPACE. **The amount is billed to your Student Account.**

Vehicle Decal Permits are \$25.00 per vehicle.

Lack of space is not just for illegal parking.

VISITOR PARKING

All visitors must come by the campus police department to obtain a visitor permit to park on campus.

ENFORCEMENT PRACTICES

Citations are issued according to printed regulations. Any concerns regarding citations should be directed to the Police Department's office at 306 Cherry Street.

LOCATION

Campus permits can be picked up at the Police Department

SPEED LIMITS

The speed limit for the entire campus is 20 miles per hour.

TRAFFIC REGULATIONS

- No persons will be permitted to ride on the **outside** of vehicle fenders, bumpers, hoods, etc.
- The Administration reserves the right to restrict the use in part or entirely, of any car, which becomes instrumental in endangering the welfare of the individual or the school.
- Bicycles may be operated on sidewalks. Bikes must have lights or reflective tape affixed to them if operated after dark.
- Three-wheelers, four-wheelers, and dirt bikes are not allowed on campus.
- All motorcycle riders must wear a helmet.

THE FOLLOWING AREAS ARE RESTRICTED PARKING FOR STUDENTS: ↓

- **ALL HANDICAPPED PARKING RESERVED FOR HANDICAPPED PERSONS**
- **ANY AREA MARKED OFF WITH ORANGE CONES, CROSSING LINES, YELLOW CURBS, BARRICADES, AND ALL OTHER "NO PARKING" AREAS.**

- **ALL OTHER PENALTIES ARE FINED ACCORDING TO VIOLATION.**

- **NOTE: ANY STUDENT WHO HAS (5) OR MORE UNPAID TICKETS WILL BE TOWED.**

- **TEMPORARY PERMITS: THESE PERMITS ARE AVAILABLE FREE OF CHARGE FOR THOSE WHO HAVE PURCHASED AT LEAST ONE DECAL AND NEED TO DRIVE A NON-REGISTERED VEHICLE ON CAMPUS. STUDENTS WHO HAVE NOT REGISTERED A VEHICLE ON CAMPUS WILL NOT BE ISSUED TEMPORARY PARKING PERMITS. THESE PERMITS WILL BE ISSUED FOR 1 WEEK AT A TIME WITH A MAXIMUM OTHREE PER SEMESTER ISSUED TO ANY ONE PERSON.**
